Dear Durbell Residents

Geagte Durbell Inwoners

It has come to my attention that residents in the area surrounding the Fairmont High School are concerned about the impact on them of the proposed use of the new Astro Turf field.

Dit het onder my aandag gekom dat inwoners in die omgewing van die Fairmont Hoërskool besorg is oor die moontlike impak wat die gebruik van die nuwe Astro turf-veld op hulle kan hê.

At a meeting with the Headmaster and Chairperson of the Governing body, we have established that they have taken the potential impact on the neighbourhood into account and are more than willing to address all further concerns.

Tydens 'n vergadering met die Skoolhoof en Voorsitter van hul beheerliggaam, het dit geblyk dat hul wel deeglik die potensiële impak op die omgewing in ag geneem het tydens beplanning. Hulle is ook meer as gewillig om verdere besware aan te spreek.

The attached letter from the school will therefore explain all the measures they have taken and give an undertaking as to how they plan to address the issues of noise and light pollution, anti-social behaviour, traffic and parking.

Ek is daarvan oortuig dat die Fairmont Hoërskool gretig is om goeie verhoudinge te handhaaf met die omringende gemeenskap. Dit is jammer dat baie van die ongelukkigheid rondom die projek ontstaan het weens gebrekkige kommunikasie.
